2026 Milliken Fog Classic AYSO Tournament Team Application Form



Application Instructions

Applications are now being accepted for entrance into the 2026 Pacifica Fog Classic AYSO Tournament, now renamed in memory of AYSO legend Mary Milliken.

The deadline to enter the tournament is **April 1, 2026**. Applications accepted by that date will be given priority for acceptance into the tournament; all others will be accepted based on any available openings.

Applications will be accepted on a first-come basis, based on a completed application. To be considered complete, your application must include all of the following:

1. Team Roster Form (printed from AYSO's software system) signed by your Regional Commissioner.

Roster Notes:

- Roster changes will be allowed up until Wednesday, April 22, 2026; after that, no roster changes. All roster changes must be approved with a signature from your Regional Commissioner.
- Rosters must be comprised solely of players who were registered and played in an AYSO 2025/2026 primary season program.
- Up to 3 guest players may be added to your roster from a neighboring AYSO Region. In this case, the guest player's Regional Commissioner must sign the roster.
- Player roster limits are as follows:

19U/16U	20 players max	11-v-11 play
14U	18 players max	11-v-11 play
12U	14 players max	9-v-9 play
10U	12 players max	7-v-7 play

2. The completed Referee Form signed by your Regional Referee Administrator (if you're not planning to bring referees, just check the box on the Referee Form and return it without the RRA signature).
3. A single region check for the total amount of the Team Entry Fee and the Referee Commitment Fee. PLEASE NOTE: **ONE CHECK PER TEAM**, please (not packaged together by region).

If accepted, it will be assumed that you intend for your team to play the entire tournament.

If your application is not accepted, you will be offered the opportunity to be placed on a waiting list, or if you prefer we will return your application to you within 48 hours of your decision.

Refund: if you withdraw your application before April 1, 2026, a full refund will be issued. If you withdraw after that time, we will only issue a refund if a replacement team can be found, less any cost to register that replacement team.
